## **US Lawmakers Call to Implement Long-Delayed Measures to Combat Campus** Antisemitism

A bipartisan group of American lawmakers has called on the US Department of Education to take steps to combat campus antisemitism that have been delayed for years.

In early February thirty-nine members of Congress sent the letter to the US Department of Education's Office for Civil Rights. House Representative Ted Lieu, a California Democrat, led the group.

The letter says the Biden administration has long put off codifying rules meant to protect American Jewish college students, including an executive order signed by former US president Donald Trump in 2019, and delayed investigations into antisemitic

complaints.

Trump's executive order from December 2019 would effectively force the US government to withhold funding from colleges and universities if they fail to confront discrimination against lewish students, by including Jews in Title VI of the Civil Rights Act of 1964. The

prohibits law

discrimination on the basis of race, color or national origin in programs that receive federal funding.

The lawmakers' February 4 letter called on the Department of Education to issue a rule on the executive order, which would formalize it as a regulation that would have the force of law. The continued on page 3

## Acclaimed Holocaust Novel 'Maus' Tops Best Seller Lists After Tennessee School District Ban

An acclaimed graphic novel about the Holocaust that was recently removed from the curriculum of a Tennessee school district has shot to the top of the best seller lists of the world's largest online booksellers.

Art Spiegelman's graphic novel "Maus" is based on interviews with his father, a Holocaust survivor, and explores both the horrors of the Nazi genocide and its traumatic aftereffects on survivors and their children. It has been widely acclaimed since it was first published in the 1980s and early 1990s and

won a Pulitzer Prize in 1992.

On Jan. 10, the McMinn County School Board voted unanimously to remove the book from its eighthgrade curriculum. Director of Schools Lee Parkison said that the issues were "rough objectionable language" and a nude depiction of a woman.

A hardback edition of "The Complete Maus," encompassing both volumes of Spiegelman's work, reached #1 on Amazon's Best Sellers list on Sunday. It remained in the #2 slot on Monday, with a paperback

process would codify the order, providing a stronger legal foundation for Title VI complaints, and give it more durability and permanence. Once formalized, the order would be less likely to be challenged in the future and would be automatically transferred between administrations.

Codifying the executive order would also send a message to college administrators that the Biden administration takes the issue seriously.

"During the previous administration, university administrators had a clear sense that the federal office for civil rights understood campus antisemitism and was focused on it," said Kenneth L. Marcus, head of the Brandeis Center, an advocacy group that combats antisemitism. "I don't think that university administrators have necessarily gotten the same impression yet from the Biden administration."

The Biden administration first

said it would issue the rulemaking in January 2022, then delayed the move until December 2022.

The Trump administration delayed issuing the regulations twice in 2020.

"After a year with historic levels of antisemitism, we ask that the administration re-prioritize the rulemaking process for Title VI and ensure it remains a priority," the letter said. RESPONSIBILITY! The congressional letter to the Department of Education also said the Office of Civil Rights has delayed investigations into Title VI antisemitic complaints in the higher education system, some dating back to 2018.

It asked the office to clarify the status of the older complaints, the reason they are unresolved and an estimated time frame for their resolution.

The slowed investigations "are delaying justice and potentially allowing discrimination to persist on campuses throughout the country," the letter said.

The letter also asked the office

The book also topped the categories of "Jewish Holocaust History," "Memoirs," and "Literary Graphic Novels."

to provide technical assistance for combating campus antisemitism through its nondiscrimination center, or directly to colleges and students.

Marcus said, "Now is not the time to hit pause on much-needed federal guidance.

"Members of Congress are right to be alarmed and to urge the Biden administration to give this issue equal priority to the other work they're doing." interprets Judaism as a race or nationality, not just a religion. Anti-Defamation League CEO Jonathan Greenblatt applauded the letter, calling it a "bipartisan effort to turn the 2019 Executive Order on antisemitism into law and ensure that the [US Department of Education] truly commits to combating it on college campuses."

The letter cited FBI statistics showing Jews were the religious group most targeted in hate crimes in 2020, and a survey by the Alums for Campus Fairness group that found a majority of respondents felt campus antisemitism was a serious problem and avoided certain places and events due to A box set of both volumes was at #1 on Barnes and Noble's Top 100 and paperback best seller lists on Monday. Barnes and Noble's supply of the book has apparently been exhausted, with the book listed as "temporarily out of stock online."

In an interview with CNBC Spiegelman said of the book's removal, "I'm kind of baffled by this. It's leaving me with my jaw open, like, 'What?'"

He described the school board's decision as "Orwellian."

Jewish lawmakers Ted Deutch, Steve Cohen, Mike Levin, Debbie Wasserman Schultz and Josh Gottheimer also signed the letter.

Trump's 2019 executive order was controversial when he signed it because it effectively interprets Judaism as a race or nationality, not just a religion.

Critics also said it would chill free expression and suppress the speech rights of Israel critics. The order endorses the International Holocaust Remembrance Alliance's working definition for antisemitism, which says some examples of Israel criticism amount to antisemitism.

A survey of campus antisemitism released on February 7 collated over 544 reported incidents on campuses in 2021.

The US Department of Education opened an investigation into alleged harassment of Jewish students at New York's Brooklyn College the first week in February 2022, following a Title VI complaint from the Brandeis Center.

## Israel Appoints First Female Attorney General

On February 7 the Israeli Cabinet approved the appointment of Gali Baharav-Miara as attorney general.

"This is one of the most important and sensitive appointments in the public service," said Israeli Prime Minister Naftali Bennett at the start of the Cabinet meeting, during which Baharav-Miara's appointment was finalized.

"At this time, given the erosion of public confidence in law enforcement, there is an important opportunity here to maintain what needs to be maintained and to correct what needs to be corrected," added Bennett, who, along with Justice Minister Gideon Sa'ar, recommended Baharav-Miara for the post. Hers had been among three names submitted by the selection committee, chaired by former Supreme Court president Asher Grunis.

"We need a good, strong and serious establishment that the public will trust," continued Bennett. "Moreover, the basic role of the attorney general is to assist the government in

implementing its

policy in the framework of the confines of the law. The government is here to govern, to function, to work for the benefit of the citizens of the state and to take the country forward."

Bennett also highlighted the fact that "for the first time, the State of Israel will have a female attorney general. Our government sees all citizens of Israelwomen and men—as being able to achieve anything."

Baharav-Miara, formerly Tel Aviv District Attorney for Civil Affairs, replaces Avichai Mandelblit, whose term as attorney general ended on January 31.

## TikTok Adds New Features to Direct Users to Reliable Information on the Holocaust

TikTok announced a slate of new features intended to reduce the spread of misinformation about the Holocaust shared on the platform and to direct users to trustworthy sources about the subject.

Beginning January 27, International Holocaust Remembrance Day, a banner pops up when users search for Holocaust-related terms and direct them to **aboutholocaust.org**, a website run by the World Jewish Congress and UNESCO, to offer

information about Holocaust history.

A link to the website will also pop up for users viewing hashtags related to the Holocaust like #Holocaust and #HolocaustSurvivor.

TikTok and other social media platforms have long been criticized for allowing Holocaust denial and antisemitism to spread unchecked on their platforms. Some Jewish content creators have also complained about being banned or censored from the platform for posting videos that

educate about Judaism or antisemitism. The social media platform, which is made

up of short userproduced videos, has pledged to crack down on hate speech shared on the platform in the past and has worked with the Anti-Defamation League to develop protocols for determining hate speech.

"Hateful behavior of any kind is incompatible with our values and the inclusive environment we are building at TikTok. We condemnantisemitism in all its forms and deploy a combination of technologies and moderation teams to remove antisemitic content and accounts from our platform, including Holocaust denial or any other form of hate speech directed at the Jewish community," the company said in an announcement.

## RFK Jr. Curbs His Enthusiasm for COVID Holocaust Analogies By Ron Kampeas, JTA

Robert Kennedy Jr., a notorious vaccine skeptic, apologized January 25 for invoking Holocaust diarist Anne Frank at an anti-vaccine rally — shortly after his wife, "Curb Your Enthusiasm" actress Cheryl Hines, publicly took him to task.

Hines, the fictional ex of Jewish comedian Larry David on the HBO show, may have curbed her husband's enthusiasm for Holocaust analogies.


"Even in Hitler's Germany, you could cross the Alps into Switzerland, you could hide in the attic like Anne Frank did," Kennedy had said at the rally on Sunday, January 23, in Washington D.C.. "Today the mechanisms are being put in place that will make it so none of us can run, none of us can hide."

The first statement from either of the couple about Kennedy's remarks came from Hines. The following day she tweeted, "My husband's opinions are not a reflection of my own," in response to a rebuke by the Auschwitz Memorial, which called Kennedy's remarks a "sad symptom of moral & intellectual decay."

"While we love each other, we differ on many current issues," Hines said.

By Tuesday morning, Kennedy was also dialing back his rhetoric.

"I apologize for my reference to Anne Frank, especially to families

that suffered the Holocaust horrors," Kennedy said in a tweet Tuesday morning. "My intention was to use examples of past barbarism to show the perils from new technologies of control. To the extent my remarks caused hurt, I am truly and deeply sorry."

The Associated Press, reporting

the apology, noted that Kennedy has used Holocaust analogies multiple times in his crusade against vaccines.

If it wasn't already clear that Hines thought her husband's Holocaust analogies were pretty, pretty bad, she followed up Tuesday morning, barely 20 minutes after Kennedy tweeted his apology.

"My husband's reference to Anne Frank at a mandate rally in D.C. was reprehensible and insensitive," she said. "The atrocities that millions endured during the Holocaust should never be compared to anyone or anything. His opinions are not a reflection of my own."

## Lebanon to Buy Gas from Israel? Why This is a BIG Deal

Will indirect gas transfers via Jordan and Syria counterbalance Iran's influence over Lebanon?

Israel has signed U.S.-brokered agreement to supply Lebanon with natural gas to reduce Iranian influence over Beirut. Israel's Channel 12 News reported January 8.

According to the report, gas from Israel's offshore Leviathan gas field will be transferred to Lebanon via Jordan and Syria. However, transfers may not begin for several years pending the repair and extension of an existing Syria-Lebanon gas line.

The unsourced Channel 12 report said the agreement was brokered by Amos Hochstein, Washington's Special Envoy and Coordinator for International Energy Affairs. Hochstein has been mediating Israel and Lebanon's maritime border dispute, and in November, he notified Jerusalem and Beirut Lebanon into the ground, has

that he would cease his efforts if no agreement was reached by March 2022, when Lebanon is scheduled to hold elections.

The American mediation goes back through the presidencies of Barack Obama and Donald Trump. At stake is natural gas in a 856 sq km area of the Eastern Mediterranean. It's not believed that this weekend's agreement addressed the border dispute.

The Lebanese pound has lost 90 percent of its value in the last two years. As a result, the government unable to provide fuel to power plants for the last six months, leaving the country with two hours of electricity a day. Filling up a gasoline tank now costs more than the monthly minimum wage.

lt of Yad is one Vashem's "Ready2Print" exhibitions aimed at promoting dialogue about the Holocaust in museums, educational and community centers and places of worship around the world.

This particular exhibit, which opened on January 27 at Shaar HaShamayim Synagogue on the Indonesian island of Sulawesi, is called "The Holocaust: How Was It Humanly Possible?"

According to the Yad Vashem website, the exhibit "deals with

major historical aspects of the Holocaust, beginning with Jewish life in pre-Holocaust Europe and ending with the liberation of Nazi concentration and extermination camps across the continent." It also documents the "remarkable return to life of the survivors."

Richelle Budd Caplan, representative of the International School for Holocaust Studies at Yad

Vashem, took part in the exhibit's opening ceremony via video.

Israel has no official diplomatic relations with Indonesia, which has the largest Muslim population in the world. Still, Yad Vashem chairman Dani Dayan said that "we will be happy to open an exhibition wherever there's interest in the memory of the Holocaust and its commemoration, and all the more so in the largest Muslim country in the world."

He added: "We see great importance in physically presenting Yad Vashem's knowledge and content outside ... Jerusalem, and we are happy to cover new grounds like Indonesia."

## Israel to Return to Space with 35 Groundbreaking Experiments

Israel will soon be sending the Rakia mission into space, with astronaut Eitan Stibbe set to take an unprecedented 35 different experiments to the International Space Station.

Israel will soon be sending the Rakia mission into space, with astronaut Eitan Stibbe set to take an unprecedented 35 different experiments to the International Space Station.

The 35 experiments were chosen from 44 proposals. The mission is led by Israel's Science and Technology Ministry and the Ramon Foundation.

The experiments cover a wide variety of different fields of study, including testing or demonstrating the viability of certain technologies, observing scientific phenomena and studying mechanisms of theorized concepts.

Some of them focus on scientific studies and come from a variety of sources, including highschool students. One of them, an experiment developed by high schoolers from Tel Aviv, will attempt to test how a microgravity environment impacts the rate that the bacteria Ideonoella Sakaiensis degrade plastic.

Other, more complex ones are developed by researchers from different companies and institutions.

One such project, known as ILAN-ES, was developed by Prof. Yoav Yair of Reichman University. This experiment will study transient luminous events, which are electrical phenomena that occur above thunderstorms.

These come in a few different varieties. At around 40 kilometers

up are blue jets that propagate from cloud top to the stratosphere. At around 90 km. are gigantic jets that head to the ionosphere. And between 50-90 km. in the mesosphere are elves (an acronym for Emissions of Light and Very low-frequency perturbations due to Electromagnetic pulse Sources), which appear as a flattened 400-km.-wide expanded glow that can last for just a millisecond, and red sprites (Stratospheric/ mesospheric Perturbations Resulting Intense from Thunderstorm Electrification, which manifest as large-scale electrical discharges that cause strange visual shapes).

Also being tested is the AstroRad radiation vest. Made by Israeli company StemRad and proudly boasting the Israeli flag, it is designed to essentially shield astronauts from space radiation. This is especially important as interest grows in expanding humanity's presence in space and renewed missions to the Moon.

As a result, the Israel Space Agency, in partnership with NASA and the German Aerospace Center, has already worked to test this technology, which will also be sent as part of NASA's Artemis 1 Mission.

During the Rakia mission, Stibbe will test the AstroRad vest under microgravity conditions, assessing its comfort and range of motion and providing critical feedback on its viability for long space voyages.

THE RAKIA mission will also have experiments focusing on food and agriculture.

One experiment, by Alef Farms,

It is very difficult to provide astronauts with quality food and nutrition, with "space food" often seen as a poor substitute.

But Aleph Farms has another possible solution: a program that would allow for the production of beef steaks in space. Essentially, it would use a sort of 3D printing to grow the meat from cells, not an actual animal.

In 2019, the company successfully tested its "bio-printing" technology in space, and it has seen considerable progress on Earth. In 2021, it successfully produced a full slaughter-free steak.

In the Rakia mission, Aleph Farms hopes to see how gravity impacts the cells that make up the building blocks of the steak, which will allow them to see if their technology can lead to both an efficient food production method for long-term space missions and to further improve their own slaughter-free meat production on Earth.

A number of other experiments focus on medical testing. These include performing blood tests without a needle and improving the immune system. But arguably one of the most interesting tests is about leukemia in children. In children, leukemia is the most common type of cancer. While current treatments are often effective, they come at a price that has punishing consequences in both the short and long term.

This experiment, led by the oncology department at Schneider Children's Medical Center for Israel in Petah Tikva, will attempt to find a new type of treatment by studying how microgravity conditions affect cancer cells. The results of this experiment will be compared to similar ones done on Earth.

The Rakia mission does not just represent a major achievement of sending all these experiments to space, however. It is also the second time an Israeli astronaut has been sent to outer space.

The former fighter pilot and businessman served in the IAF under Ilan Ramon, the first Israeli astronaut, who died tragically in 2003 when the Columbia space shuttle exploded upon reentry. The Ramon Foundation set up in his honor is helping to lead this mission.




## Tufts University Unveils Plan on Antisemitism as More Than Half of Jewish Students **Report Incidents**

Tufts University is taking new steps to address antisemitism based on a "troubling" survey showing that Jewish students are concealing their identity to join campus groups, President Tony Monaco revealed in late January.

"More than half of Jewish student respondents reported to have observed some form of antisemitism a Tufts," Monaco said in a statement. "Disturbingly we also heard from some lewish students who felt that, in order to be welcome in student organizations supporting social justice, they had to hide their Jewish



identities."

Faculty and staff also reported that campus issues related to antisemitism, including those surrounding the Israeli-Palestinian conflict, had lately become more difficult.

High-profile campus incidents in recent years have included a student senate measure to boycott Israel passed on the eve of Passover in 2017, a 2020 resolution blaming Israel for racial tension in American policing, an attempt by Tufts Students for Justice in Palestine to remove a Jewish member of a student government body, and, most recently, the theft of a mezuzah from a student's doorpost.

Last December, the university, working with Hillel International and a private consultancy, formed an ad hoc committee to study antisemitism on campus, Monaco

said. The committee recommended new training on antisemitism for students, faculty, and staff, and that university orientation for freshmen include feature programs on antisemitic bias.

Tufts has also joined the 2021-2022 Hillel International Campus Climate Initiative (CCI) cohort, an initiative in which universities respond to antisemitism based on the experiences of Jewish students, faculty, and staff.

"We are very encouraged by President Monaco's leadership in undertaking this comprehensive survey on antisemitism and for his firm commitment to implementing its recommendations," Rabbi Naftali Brawer, Executive Director of Tufts Hillel, told The Algemeiner. "We are fortunate to have in President Monaco a friend and partner, determined to ensure that Jewish life can continue to flourish at Tufts University."

The committee also proposed hosting more forums on the Israeli-Palestinian conflict. A universitywide advisory, Monaco added, will be commissioned to counsel senior school officials "on the best ways to approach the implementation process."

"We are not immune from the rise in antisemitism across the nation, including the alarming incident in Texas just this past week," Monaco continued, alluding to the antisemitic attack on a Reform synagogue in Colleyville, Texas. "It is incumbent that we take active steps to combat it on our campus. You have my commitment that we will work on these recommendations to improve the quality of Jewish life at Tufts and work to combat campus antisemitism in its various forms."

## Barnes & Noble Removes 'The Protocols of the Elders of Zion' from its Website Following Social Media Outcry

Twitter users began tweeting about an online listing on January 25, which had been selling the famously fabricated antisemitic text for \$24.95 on the book retailer's website. The retailer said in a statement to the Jewish Telegraphic Agency that the book was fed automatically to the website from "standard industry databases" and that the company would "take prompt action to remove" the title.

Twitter users also objected the description of the book on the site, which summarized at length the book's fictional description of a Jewish plan for global domination

and justified its sale as "an interesting book which deserves to be studied in the same way the 'War of the Worlds radio broadcast duped thousands...We neither many support nor deny its message, we simply make it available for those who wish a copy."

In their statement to JTA, a representative for Barnes & Noble wrote that the bookseller does the "utmost to diligently monitor such submissions for violations of our content policy." According to the statement, the book was never stocked in their bookstores.

"We regret that it was listed

inadvertently. As soon as we are made aware of any such offending titles, we take prompt action to remove the offending titles in accordance with our policy, as we did with this title," said the representative.

While Barnes & Noble was the main focus of social media users' outrage, it was reported in the Jerusalem Post yesterday that other top online booksellers such as Walmart, Book Depository, Thrift Books and Hudson Books were selling dozens of versions.

## Biden Yanks Trump Appointee Who Spoke to White Supremacists from **Commission that Monitors Holocaust Sites**

President Biden loe removed from a commission that monitors Holocaust sites a Trump appointee



with ties to white supremacists.

In a letter obtained by a reporter for Politico, on January 14 the White House asked Darren Beattie to resign from the Commission for the Preservation of America's Heritage Abroad by the end of the day or be removed.

The commission identifies and works to secure the preservation of historical sites in Europe, such as cemeteries, monuments and Holocaust killing sites, that are associated with the heritage of U.S. citizens.

President Former Donald Trump's appointment of Beattie to the commission in 2020 stirred controversy among Jewish groups and led to demands for his removal. It was one of several appointments of young loyalists to prestigious commissions that Trump made after he lost the election.

Beattie, who is Jewish, had been a speechwriter for Trump until it was revealed in 2018 that he had two years earlier attended a conference of the H.L. Mencken Club. According to the Southern Poverty Law Center, the conference "has hosted some of America's most prominent white nationalist ideologues in the past and serves as a safe space for professors to vent their racist views."

Beattie appeared the at conference on a panel with Peter Brimelow, a white nationalist who runs the anti-immigrant website VDare. Beattie has vociferously defended Trump's policies limiting the entry of Muslims into the United States.

The same day he sacked Beattie, Biden named seven new commissioners to the Commission for the Preservation of America's Heritage Abroad, including two with ties to Jewish organizations.

## US Judge Orders Jewish Victims to Pay \$159,000 to Antisemites

Judge orders \$159K payday for antisemitic synagogue harassers, victims ordered to pay their legal fees. Case could go to Supreme Court By Lauren Marcus, World Israel News

A Michigan district court judge ordered several synagogue members, including a Holocaust survivor, to pay some \$159,000 in legal fees for antisemitic protesters who regularly demonstrate outside the Jewish house of worship, ruling that a lawsuit filed by the congregants attempting to stop the ongoing harassment was meritless and frivolous.

Since 2003, antisemitic and anti-Israelprotestershavegatheredoutside of the Beth Israel Congregation in Ann Arbor, intentionally timing their demonstrations to align with Shabbat services in order to disturb and accost worshippers on the Jewish day of rest. In 2019, plaintiffs Marvin Gerber and Miriam Brysk, who is a Holocaust survivor, filed a lawsuit against the city and the protesters, arguing that the protests infringe upon their First Amendment right to worship freely.

Because protesters regularly confront congregants and hold signs bearing antisemitic messages, while yelling antisemitc phrases at worshippers, the plaintiffs said that the protests go beyond freedom of speech — amounting to intimidation and harassment, as individual Jews are targeted.

"One could colorably [sic] argue that signs that say 'Jewish Power Corrupts' and 'No More Holocaust Movies' directly outside a synagogue



attended by Holocaust survivors and timed to coincide with their service are more directed at the private congregants than designed to speak out about matters of public concern," acknowledged Judge Victoria Roberts.

Despite this finding, Roberts said that because the protests take place on a public sidewalk, the plaintiffs have no basis for trying to stop them and are therefore responsible for paying \$159,000 in legal fees for the demonstrators.

She categorized the lawsuit as a meritless, baseless attempt to "silence" the protesters, and in an unusual move, singled out the plaintiffs' attorney, Marc Susselman, ordering that he also pay damages to the demonstrators.

Roberts wrote that as an attorney, Susselman should have known better than to pursue "frivolous" claims against the demonstrators and that he must also be held personally liable for financial damages.

Susselman said he is planning to appeal the decision to the U.S. Supreme Court.

## Jonathan Pollard's Wife Esther Passes Away at 68

Esther Pollard, wife of Jonathan Pollard, who was convicted of spying on behalf of Israel and served more than three decades in an American prison, died in a Jerusalem hospital on January 31.

Born Élaine Zeitz in Toronto, Canada, she married Pollard in 1993 while he was in prison and worked as a tireless advocate for her husband's release.

The pair originally met as

Jonathan Pollard was released from prison in 2015 but was subject to parole conditions, including an electronic tracking bracelet and a blanket ban on leaving New York.

Shortly after those conditions were removed in 2020, the pair immigrated to Israel, settling in Jerusalem.

## Tourist Arrested for Making Nazi Salute at Auschwitz 'As a Joke'

Security at the Auschwitz-Birkenau Museum and Memorial in Poland saw her in the act, detained her, and contacted police.

## Laser Defense System Will Be Ready to Intercept Missiles in a Year - Bennett

The laser system will protect Israel from missiles, rockets, drones and other threats.

Israel will surround itself with a defensive "laser wall," with new missile interception technology to be ready within a year, Prime Minister Naftali Bennett announced in a speech at the Institute for National Security Studies in Tel Aviv in early February.

The IDF will begin using the laser interception system in the next year, first experimentally and later operationally, starting in the South.

"This will allow us, in the mediumto long-term, to surround Israel with a laser wall that will defend us from missiles, rockets, UAVs and other

threats that will essentially take away the strongest card our enemies have against us," Bennett said.

The Defense Ministry successfully intercepted drones with the powerful airborne laser system installed on light aircraft in June. The system downed several UAVs at a range of one kilometer with a 100% success rate. The ministry intends to build a laser with a power of 100 kilowatts that will have an effective range of 20 km.

Bennett explained that today a terrorist in Gaza can launch a rocket

into Israel that costs hundreds of dollars to make, while the Iron Dome battery shooting down the rocket costs tens of thousands of dollars.

"This equation doesn't make sense," the prime minister stated. "It allows [the terrorists] to launch more and more Kassams and for us to shed many millions on a 'lightning strike' and billions during a campaign. We decided to break the equation, and it will be broken in only a few years."

At that point, Bennett said, Israel's enemies "will invest a lot, and we will [invest] a little. If you can intercept a missile or rocket with an electric pulse that costs a few dollars, we are weakening the ring of fire that Iran has built on our borders."

Israel will offer the laser technology to its regional allies that are also facing threats from Iran and its proxies, the prime minister said.

Bennett repeated his comparison of Iran to an octopus, sending its tentacles – proxies – to wreak havoc throughout the Middle East, and growing stronger all the time.

"The campaign to weaken Iran has

## Thousands of Rare Antiquities Recovered in Unique Pre-dawn Raid

Complex months-long joint operation leads to arrest of antiquities thief By Judith Sudilovsky, The Jerusalem Post

Thousands of rare antiquities were confiscated and a Palestinian antiguities dealer and thief was arrested in a complex pre-dawn operation in the Nablus area on February 7 following a monthslong undercover investigation and intelligence surveillance by the Civil Administration (COGAT).

Rare coins from among the oldest used in the Land of Israel, as well as relics from the Persian and Hellenistic periods and coins from the time of the Great Jewish Revolt were among the confiscated finds. They are estimated to have a value of hundreds of thousands of shekels.

The joint operation that took place in the village of Qalil near Nablus included forces from the Border Police, the Archaeology Unit of the Civil Administration, the Coordination and Liaison Administration for Nablus and the IDF.

The forces also confiscated equipment used by the suspect in the theft of the antiquities.

According to COGAT, the operation was part of the extensive efforts undertaken by the Civil Administration's Archaeology Unit over recent years to preserve archaeological finds and root out the theft of antiquities in the Judea and Samaria area with the help of advanced technology.

"The Civil Administration is pursuing many avenues, both public and confidential, in order to preserve the archaeology of Judea and Samaria," said Civil Administration head Brig.-Gen. Faris Atila. "Following a long and intricate operation, thousands of rare archaeological items that had been stolen by a specialist in

archaeological theft were located. The operation was important, with significance in breaking the chain of traffic in antiquities in Judea and Samaria. The Civil Administration



will continue working tirelessly against the shameful phenomenon of destruction and theft at the

archaeological sites of Judea and Samaria, protecting the cultural and historical assets of the area."

The antiquities dealer was arrested and transferred for further interrogation by investigators of the Civil Administration's Archaeology Unit. An indictment against him is currently being drawn up and will be submitted to the military prosecution.

begun," he said. "This campaign is in all dimensions: nuclear, economic, cyber, open and secret actions, alone and in cooperation with others. The weaker Iran is, the weaker its proxies are. The hungrier the octopus is, the more its tentacles shrivel."

Bennett expressed hope that the nuclear talks between world powers and Iran "will end without an agreement, because that agreement is bad for Israel."

"Removing sanctions and flooding the [Iranian] regime with billions of dollars means more rockets, more UAVs, more terrorist cells, more cyberattacks and propaganda operations," he said.

The prime minister pointed out that the Iran Revolutionary Guard Corps and its proxies have been actively attacking the United Arab Emirates and other countries while the Vienna talks are ongoing.

"That is the definition of negotiations under fire. That's blackmail," he said.

Israel's strategy to fight back against Iran will stand regardless of the





results in Vienna, because "even with an agreement, we think the Iranians will continue to be the Iranians," he added.

"If an agreement is signed and the flow of dollars is renewed, we all understand Iranian aggression will only increase in the region."

In addition, Bennett pointed



out that the sunset clauses in the 2015 Iran nuclear deal, which the delegations in Vienna are seeking to revive, expires in a short time, at the end of 2030.

With US Ambassador Tom Nides in the audience, Bennett said that Washington's interests and Jerusalem's "do not always overlap."

"Their interest in our region



There is "no longer one global policeman," he said.

"There are no vacuums in the geopolitical arena," Bennett stated. "Any place that is cleared is immediately taken. The United States' place in the region can be filled – God forbid – by forces of terror and hate, and it could be filled by Israel."

Israel's allies in the region could be part of a "multidimensional alliance" against forces that seek to destabilize the Middle East, he said.

## Israeli Arab Party Leader Mansour Abbas Dismisses Charge of 'Apartheid' State: 'Our Fate Here Is to Live Together'

Israeli Arab leader Mansour Abbas — head of the Islamic Ra'am party and a Member of the Knesset, who joined the country's governing coalition — said he would not use the word "apartheid" to describe relations between Arabs and Jews in Israel

Asked at an online conversation organized by the Washington Institute for Near East Policy about hearing that label applied to the Jewish state, Abbas said: "I would not call it apartheid."

"I am in the coalition, and if I want to be inside the government, I could be in the government too," Abbas emphasized, according to comments translated from Hebrew.

"I usually try not to be judgmental. I'm not trying to say you are racist or the state is racist, or this is an apartheid state or not an apartheid state," he explained. "My role as a political leader is to try to bridge the gaps, improve the distortions and to create more justice not only between Jews and Arabs, but also among Arabs and among Jews."

Abbas' comments follow a report in early February by the NGO Amnesty International accusing Israel of practicing apartheid. The report claimed that "Israel imposes a system of oppression and domination against Palestinians across all areas under its control: in Israel and the OPT ('Occupied Palestinian Territories'), and against Palestinian refugees, in order to benefit Jewish Israelis."

Israeli leaders flatly rejected those charges, which Israeli Foreign Minister Yair Lapid called "divorced from reality."

At the same time, Abbas said at the virtual event, he was not disregarding Amnesty's findings or those by other human rights organizations.

"This is an opportunity for us to look at what is happening, to be introspective, to see what we can fix and what we can change," he proposed.

A dentist by profession and an advocate for Israel's Arab community, Abbas made history last year when he led Ra'am to become the first Arab party ever to join Israel's governing coalition.

"Everything I am trying to do is historical," Abbas contended. "My role is to try and show lews and Arabs a new way in which they can live together and in which each side will realize itself as the collective and as individuals within this framework which is called the State of Israel. I am not trying to please one group or another. I seek to show Arabs and Jews how to live together in the context of Israel."

Abbas described himself as an Arab, a Palestinian, a Muslim, and a citizen of the Israeli state adding that when he was elected to the Knesset, he was looking for a partnership and to make change

from within.

#### Calling to Create Nazi party, Brazil Podcast Star Sparks Outrage, May Face Charges Bruno Aiub fired after interview on his show, one of the most listened to in Brazil; also said 'if someone wants to be anti-Jewish, I think they

have the right to be'

A Brazilian podcaster who said on air that the South American country should have its own Nazi party triggered outrage February 8, with prosecutors saying he could face charges.

"I think there should be a Nazi party recognized by law," said Bruno Aiub in an interview with lawmakers for his Flow Podcast show, one of the most listened to in Brazil, with 3.6 million subscribers on YouTube and one million on Twitch.

He said during the program that "the radical left has much more space than the radical right, both should have space," and called for

the creation of a Nazi party.

"If someone wants to be anti-Jewish, I think they have the right to be," added the presenter, who later apologized and claimed he was "totally drunk" when he made the comments.

The video of the show was taken down from social media and the production house, Estudio Flow, said it had fired the host.

Many Jewish associations, institutions and political figures condemned the statements.

"Hate speech and the defense of hate speech have terrible consequences for humanity, and

Nazism is the greatest historical proof of this," said the Brazil Israelite Confederation.

"No, defending Nazism is not freedom of expression," the German Embassy in Brazil said on Twitter. To defend Nazism "is to disrespect the memory of the victims and survivors of this regime and to ignore the horrors it caused," it added.

The public prosecutor's office announced in a press release that it was going to analyze "the content of the statements" as part of an investigation for "the alleged offense of apologizing for Nazism."

A centrist lawmaker, Kim Kataguiri of the Podemos party, who was taking part in the broadcast, was also a target of the prosecution's investigation for having "claimed that Germany had made a mistake by criminalizing the Nazi party," according to the press release.

## OP-ED Antisemitic or Not? Why it is Important to be Accurate on Antisemitism

It is essential to be accurate when using the term antisemitism. When one demonizes Jews or the Jewish State, applies double standards or delegitimizes either, it is absolutely appropriate to speak of antisemitism.

Thus, when the media covers Israel differently than any other country or conflict, critics correctly call this antisemitic. Nonetheless, it is important to differentiate between premeditated biases with a particular vengeance, such as is often the case with the New York Times, or when things stem from a lack of knowledge or unacceptable custom.

The list of factors to consider when speaking about the media is long and includes such things as what supposed experts are interviewed, what wording or terminology is used, etc. Frequently, the content of articles may be accurate and include all information, while its headlines or photographs will nonetheless create a bias against the supposed aggressor, such as after an attack on Israel. Instead of truthful headlines, which state who initiated a conflict, such as "Palestinian terrorists kill...," typical headlines (which often do not necessarily come from the authors of the articles themselves, by the way) will focus on Israel's reaction, such as "Israel bombards..."; "kills..."; or "Israel this or that." Only the bylines might mention what instigated Israel's self-defense. Other times, one has to read an entire article to understand that Israel is not a brutal Goliath which attacks at will.

Thanks to the IHRA working definition of antisemitism, there is now a guideline to which the media

and others can be held accountable. The availability of such a widely accepted definition has also helped in narrowing down antisemitic hatred stemming from organizations like BDS, which have persistently been proven to be directed against not only Jews in all of Israel but against lews all over the world. Likewise, there can no longer be talk of criticism of Israel when the Jewish State is being demonized or when hostile regimes seek to eliminate it. But where does this leave the aforementioned subtleties in the media? Is an organization, an individual, or an entire newspaper antisemitic, because of the publication of one questionable article, headline, or photograph?

A good example in this context is the recent list of the top

antisemitic incidents, which the Simon Wiesenthal Center (SWC) published. While there can be no doubt that entities such as the Iranian regime or Hamas, which both seek to destroy Israel, belong on such a list, Katharina von Schnurbein, European Coordinator Commission on combatting Antisemitism, the Central Council of Jews in Germany, along with many prominent organizations and activists, rightfully questioned how the Antisemitism Commissioner of the State of Baden-Württemberg, Michael Blume, could be included in such a list. Not only do fellow German Antisemitism Commissioners and lewish communities vouch for Blume. but he has also been praised by those closely working with him for his stand against BDS and all forms of antisemitism.

This is where the fine line comes into play. Naturally, there is a reason why the SWC criticized Blume, but should undiplomatic reactions or inappropriate likes on social media years ago justify him being on a list with the likes of Iran? His inclusion, which will hopefully be reversed, in fact, demeans the importance of the definition of antisemitism and highlights why it is so important to use the term 'antisemitic' judiciously.

Questioning, opposing, and reacting to things is an absolute necessity, but it is ever so important to be accurate and to make sure we do not fall into our inner trap of using the accusation of antisemitism in an inflationary manner. Our accuracy with using the term will keep it strong and effective.

## Israel's Future Submarines Seen as Key Development Towards Regional Naval Ascendency

JNS The announcement on Jan. 20 by the Israeli Defense Ministry and Germany's ThyssenKrupp Marine Systems of the procurement of three new advanced submarines for the Israeli Navy marks a key milestone in the evolution of Israel's fleet, which will consist of six submarines.

In a reality in which Israel's adversaries are armed with missiles that can strike any land point in the state, the strategic value of Israel's underwater long arm is on the ascent, even more so in light of the expected advanced capabilities that the new Dakar-class submarines are expected to carry onboard.

Israeli Defense Minister Benny Gantz noted that the new vessels "will upgrade the capabilities of the Israeli Navy and will contribute to Israel's security superiority in the region"—hinting at their multiple abilities, which will include the capacity to remain submerged for more extended periods, gather intelligence off enemy coastlines and strike targets deep in enemy territory or at sea.

The 3 billion euro (\$3.4 billion) deal will see the first Dakar-class submarine arrive in nine years, as well as the construction of a submarine simulator in Israel, and spare parts supplies. The German government will subsidize a portion of the agreement via a "unique grant," said the Defense Ministry, in accordance with an agreement signed between the countries in 2017.

The Defense Ministry declined to comment on a report by The Marker business daily published in recent days, which said that

Thyssenkrupp had significantly raised the procurement's price, from 1.8 billion (nearly \$2.1 billion) to 3 billion euros (\$3.4 billion). The report said that Israel will likely pay 2.4 billion euros (\$2.7 billion) out of the total price tag (with Germany subsidizing the rest).

Alongside the deal, the two sides signed an industrial-strategic cooperation agreement that will see Germany's Federal Ministry of Economics and Technology invest 850 million euros (\$973 million dollars) in Israeli industries, including defense companies.

#### 'Most expensive military platform in IDF's inventory'

Past experience has shown that much time passes from the stage of formulating the specifications of new submarines to the production stage.

According to Professor Rear Adm. (Res.) Shaul Chorev, head of the Haifa Research Center for Maritime and Policy Strategy at the University of Haifa, and a former Israel Navy Submarine Flotilla commander, it took no less than 17 years for the 1980 specifications of the firstgeneration German-made Dolphin submarines to be turned into final vessels.

It is those three late 1990s-era vessels that will be replaced by the Dakar series. They will join three new-generation Dolphin submarines—two of which, the INS Rahav and INS Tanin, are already in the Israeli Navy's possession and the third, the INS Dragon, reportedly expected at Haifa Base's submarine terminal next year. These vessels are equipped with air-independent propulsion (AIP) systems that generate electricity from hydrogen and water.

These diesel-powered submarines can thus remain submerged for longer, and their quiet engines mean they can evade enemy sonar detection with efficiency.

The AIP submarines are equipped with technology that goes back to the early 1990s, so the Dakar submarines will require much newer technological capabilities. This will likely involve, among other things, new engine designs, generators and electronic-sensor systems rather than the older periscopes.

Past disputes over the correct size of the submarine fleet that serves Israel's needs have been a common feature between Israeli governments and the Israel Defense Forces.

It was former Prime Minister Benjamin Netanyahu who overruled the IDF's preference for five vessels in the past, opting for six instead, and his decision received the approval of an official ministerial acquisition committee.

It appears as if Netanyahu's call was the correct one to make in light of the dazzling contribution each such platform—the most expensive military platform in the IDF's inventory, pricier than fighter jetsprovides to state security.

"Five is the minimum; six is the optimal [number]. Six submarines will provide us with much flexibility, but we can make do with five," Col. L., then head of the Israeli Navy's Submarine Department, told Maariv in 2018.

Each submarine is able not only to travel covertly towards enemy states, gather intelligence and strike targets with great precision, but the platform also, according to international media reports, serves as a fundamental pillar of Israel's nuclear deterrent posture and second-strike capability.

Palestinian Authority and the Hamas terror group for telling a business conference in Tel Aviv that the "state of Israel was born a lewish state and that's how it will remain."

"I tried to say to both Arab and lewish society that the real discussion is not about the identity of the state — that exists, that has been accomplished. That's a fact," Abbas asserted. "But the real discussion should be within the state of Israel; the definition of it, in my view, it will not change. But what is the place of the Arab minority inside the State of Israel and inside of Israeli civic identity? That is the question that will decide what Israel is going to be like."

Abbas stated that he was "proud" to be able to create this partnership with the government.

"We brought a lot of budgets

to the Arab society to education, to integrate workers in high tech and to farmers," he said. "I'm very proud that we have been able to give people hope that Jews and Arabs can trust each other."

Abbas noted that in some public opinion polls, 60 percent of Arabs surveyed support his party agenda, and that he has been winning over voters from other Arab parties like the Joint List. The Ra'am leader is confident that if the party can demonstrate achievements, it will earn more than 85 percent of the Arab public's support in Israel.

"Our fate here is to live together and we can decide how we want to live together: With fights, conflict, hatred, or with those who have already offered peace, security and tolerance," he said. "I think we all inside ourselves know what the answer is."

**GOLDIE'S HONEY DOUGH FOR HAMANTASHEN** 

- $2^{1}/_{2}$  cups flour  $\frac{1}{2}$  cup sugar

1 cup Crisco

- $\frac{1}{1}$  teaspoon salt
- $2^{1/2}$ , teaspoons baking powder
- $\frac{1}{1}$  cup honey

- 2 eggs, beaten
- 1 Tablespoon lemon juice
- $\frac{1}{2}$  teaspoon grated lemon rind

Preheat oven to 350 degrees. Thoroughly cream the Crisco and sugar together. Add honey. Beat in eggs, lemon juice and lemon rind. Sift together the flour, baking powder and salt, then stir into the egg mixture and form into a soft dough. Toss lightly on a floured board. Roll out to <sup>1</sup>/<sub>4</sub> inch thickness and cut into circles. Fill with desired filling, pinch into triangles and bake for 18 to 20 minutes at 350 degrees until golden brown.

#### POPPY SEED FILLING WITH RAISINS AND DATES (Milchig)

1 cup poppy seeds	1 cup chopped raisins	
1/2 cup milk	${}^{1}\!I_{4}$ cup finely chopped nuts	
<sup>1</sup> / <sub>4</sub> cup honey	½ teaspoon cinnamon	
1 cup finely chopped dates	½ teaspoon nutmeg	
Cook all ingredients over low heat and stir occasionally until almost all liquid is evaporated.		

Yields 2½ cups.

#### APRICOT-ORANGE-HONEY FILLING (Pareve)

2 cups finely chopped dried apricots 1 cup orange juice

2/3 cup honey Zest of  $1/_{2}$  orange

Bring to boil in saucepan. Reduce heat and simmer 15 minutes until soft and liquid is absorbed (Add water if needed). Cool before filling .

#### FIG, PECAN & COCONUT FILLING (Pareve)

1/4 lb. small, dried figs (Mission figs a good choice), stems removed, halved 1/2 cup raisins

1/4 cup pecans 1⁄4 cup plum jam 1/4 cup flaked coconut

Chop figs and raisins together in a food processor. Add pecans and chop for a few more seconds, then transfer to a mixing bowl and stir in remaining ingredients.

#### CHOCOLATE-ALMOND-ORANGE FILLING (Pareve)

2 oz. semi-sweet chocolate 1 cup blanched almonds 7 Tbsp. sugar

Scant 3 Tbsp. orange liqueur 2 teaspoons grated orange rind 1 large egg, beaten

Melt chocolate in medium bowl over simmering water or microwave. Allow to cool. Grind almonds with 2 tablespoons sugar in food processor until fine powder (grinding with sugar lessens chance that almonds will process into almond butter! Add rest of sugar and the egg. Process till blended. Add chocolate and orange liqueur and blend together. Remove to a bowl and stir in orange rind.

#### DATE-RAISIN-WALNUT FILLING (Pareve)

<sup>1</sup>/<sub>4</sub> cup coarsely chopped walnuts 2 cups pitted dates

 $1/_{2}$  teaspoon cinnamon 1 teaspoon grated lemon rind (optional)

<sup>1</sup>/<sub>2</sub> cup sultana raisins

In food processor, with steel blade, process dates with raisins, rind and cinnamon until minced, about 15-20 seconds. Add nuts with one or two quick on/off turns. (Can prepare ahead of time and refrigerate).
